- 5) When rented out for Public Functions like Marriages, Social/Cultural Functions of the Tribals/SC in and around Forest Area : Rs.300/day.

- Suites in Dormitory (Single Occupancy) : Rs.100/Day/Person
- Dormitory (Double occupancy) : Rs.200/Day/Person Suite
- Tribals/Harijans and Local Communities together with their Social/Cultural needs (Additional occupancy Rs.30/person/day) : Rs.50/Day/Suite
