ORDER

Government as per GO(P)668/97/Fin. dated 6.8.1997 constituted an Expert Committee under the chairmanship of Chief Secretary to study about the non-tax revenue of the State. The Committee among other things recommended revision of rates with regard to Forest Department. Among the items proposed for revision the Committee suggested enhancement of rates levied as penalty for delayed delivery of timber-coupe extensions for timber (hard wood) and firewood billets and the rates for pass extension for timber softwood and semi hard wood. The present rates for the above are prescribed as per Government Order read as 1st paper above.

Government accepts the recommendation of the expert Committee and hereby order the enhancement of the rate as per the following.
