Public Services Verification of character and antecedents of candidates already in Government service or retrenched from Government service and advised for appointment again revised – orders issued

ORDER

In partial modification of the instructions appended to the G.O. read as first paper above and in supersession of the orders in the G.O. read as second paper above, Government are pleased to issue the following orders.

- (i) No detailed verification of character and antecedents of candidates already in Government service is necessary except for appointment to sensitive posts.
- (ii) Any person in Government service who is advised for a post not declared as sensitive may be appointed on the basis of the certificate of his superior officer or entries in his character roll.
- (iii) Are trenched person readvised for appointment within a period of one year, may be appointed to a non-sensitive post on the basis of a certificate of his superior officer or entries in character roll. No second check by Police would be necessary.
- (iv) Detailed verification would be conducted in the case of retrenched personnel selected for appointment to sensitive posts or advised after a period of one year of retrenched.

A list of sensitive posts under the Government is herewith appended.

The Public (Rules) Department may take action if necessary to amend Rule 10 of the Kerala State and Subordinate Services Rules (195) Part II to give effect to the above orders.
