ORDER

In the circumstances stated by the Public Service Commission in their letter read as third paper above Government order, in partial modification of the orders contained in para 2 of the G. P. read as first paper above, that the following procedure will be adopted for the recruitment to the post of L. D. Clerk on Rs. 80-160 in the Registration Department.

2. The Public Service Commission will conduct a separate handwriting test in Malayalam, Tamil, or Kannada as the case may be, for recruitment as L. D. Clerk in the Registration Department along with Selective Test for clerks conducted every year. It will be notified that a pass in a separate handwriting test securing at least 60% marks will be an essential additional qualification for recruitment as Lower Division Clerk in the Registration Department and that those who desire to be considered for appointment in the Registration Department also, should appear for this test in addition to the Selective Test for clerks. In the selective list prepared by the Commission based on the Clerk's test, those who have appeared for this special handwriting test and have secured 60% marks and above will be marked as eligible for appointment in the Registration Department as well.
