PAY REVISION—TYPISTS IN NON-SECRETARIAT DEPARTMENTS—IMPROVEMENT OF PROMOTION PROSPECTS—ORDERS ISSUED—SCALE OF PAY OF U.D. TYPYST PROMOTED AS FAIR COPY SUPERINTENDENT PRIOR TO 1-7-1978—CLARIFICATION ISSUED.

In the Government Order read as first paper above, the scale of pay of Fair Copy Superintendent was revised from Rs. 330-575 to Rs. 450-785 from 1-7-1978. The scale of pay of Senior Grade Typist was also the same. Subsequently, as per the Government Order second cited, the revised scale of Rs.450-785 allowed to Fair Copy Superintendent, in the Government Order cited first, has been substituted by the scale of Rs.520-900. It has also been stipulated in that order that the above scale will be admissible only to those who are promoted as Fair Copy Superintendent from the category of senior Grade Typists. Thus in the case of a U.D. Typist promoted as Fair Copy Superintendent, he will be eligible only for his grade pay plus a special pay of Rs.20 p.m from 1-7-1978.

2. Certain Heads of Departments have sought clarification as to how the pay of a Fair Copy Superintendent who was promoted from the cadre of U.D. Typist is to be fixed, on 1-7-1978.

3. Government have examined the question in detail. It is not fair to apply the restriction introduced in the Government Order cited second (i.e. that U.D. Typist promoted as Fair Copy Superintendent will be allowed only his grade pay plus special pay of Rs.20) in the case of those who were already holding the post of Fair copy superintendent in the pre-revision scale of Rs.330-575 as on 30-6-1978/1-7-1978. They should be allowed the benefit of the revised scale of Rs.450-785, which they were already getting, till the issue of the Government Order cited second. Accordingly, Government wish to clarify that U.D. Typist promoted as Fair Copy superintendents prior to 1-7-1978, who are drawing pay in the re-revision scale of Rs.330-575 and who are not eligible for the revised scale of Rs. 520-900 sanctioned for the post of a Fair Copy Superintendent in the Government Order cited second, will be allowed to retain the revised scale of Rs. 450-785 as personal to them. They will not however be eligible for the special pay of Rs.20 per mensem.
