ORDER

In the Government Order read as first paper above, Government issued orders allowing the benefit of a higher grade with effect from 1-7-1979 to all Non-Gazetted Officers who remain in the entry grade without a promotion in the normal course, on completion of 13 years of service in the entry grade. Detailed instructions for implementation for the above orders were issued in the Government Order second cited.

2. Certain Heads of Departments, have sought clarification whether, in the case of last grade employees, the total service, put in by them in different last grade posts can be reckoned for computing the 13 years service, for granting higher grade as per the Government Orders read above. Some of the service organizations of last grade employees have also Raised the same question.

3. Government have examined the question in detail and are pleased to issue the following clarifications:--

(a) In the case of last grade employees, their full time service in the various categories of last grade service (both in the regular service and full time contingency service) will be reckoned for computing the 13 years' service, for granting higher grade, in terms of the Government Orders cited.

(b) Broken periods of service in the last grade service (either in the regular service or in a full time contingency service) reckoned for the grant of normal increments will also be taken into account for purpose of calculating the 13 years of qualifying service, for allowing grade promotion.
