NOTIFICATION

In exercise of the power conferred by the proviso to Article 309 the Constitution of India, the Governor of Kerala hereby makes the following amendment to the Kerala Service Rules, namely:-

C.S.No.23/62/Fin. Dated 8-8-1962.

AMENDMENT

In Part III of the said rules, the existing rule 146 shall number as 146(a) and after the as so renumbered the following shall be inserted as 146(b) & (c) , namely:-

- (b) when an Officer is likely to retire before the death –cum- retirement gratuity due to him can finally be assessed and settled as per rules the audit officer may sanction the disbursement of not more than of the amount of gratuity to which after the most careful summery investigation that he can make without delay, he believes the officer to be entitled on the basis of his qualifying service. Similar payment of gratuity may also be authorized in the appropriate proportion to the nominees and in cases where no valid nomination subsists to the surviving members of his family in accordance with the relevant orders issued from time to time in the event of death of the government servant. In all cases, the anticipatory payment of death-cum-retirement gratuity should be made after the recipient has executed a declaration as follows:-

Where the (here state the designation of the officer sanctioning the advance) has consented provisionally to advance to me the sum of Rs..... in anticipation of the completion o the enquiries necessary to enable the Government o fix the amount of death-cum-retirement gratuity payable to me ( as the nominee/ legal heir of Mr.....) I, hereby acknowledge that in accepting this advance I fully understand that the death –cum- retirement gratuity payable to me is subject to revision on the completion of the necessary formal enquiries and I promise to raise no objection to such revision on the

ground that the provisional death-cum-retirement gratuity now to be paid to me exceeds the death-cum-retirement gratuity which may finally be sanctioned to me. I further promise to repay any amount advanced to me in excess of the death-cum-retirement gratuity that may be finally sanctioned to me.

(c) when it is likely that the payment of a Family pension after final assessment, will be delayed and will cause undue hardship to the parties concerned the audit officer shall sanction the disbursement of anticipatory Family pension provided such pension does not exceed  $\frac{3}{4}$  of the amount admissible on the basis of the most careful summary investigation that he can make without delay. The person, who receives such payment, should sign a declaration as below:-

Where the (here state the designation of the Officer sanctioning the advance) has consented provisionally to advance to me the sum of Rs..... a month in anticipation of the completion of the enquires necessary to enable the Government to Fix the amount of Family pension due to the late Shri.....I (widow etc) hereby acknowledge that in accepting this advance, I fully understand that the family pension in respect of late Shri.....is subject to revision on the completion of the necessary formal enquiries and I promise to raise no objection to such revision on the ground that the provisional family now to be paid to me exceeds the family pension which may finally be sanctioned I Further promise to repay any amount found to be in excess of the family that be finally sanctioned.
