Sub: H&FWD - Medical Reimbursement and Interest Free Medical Advance -
Austerity measures - Further instructions - Reg:-

It has come to the notice of Government that a large number of cases for claiming Medical Reimbursement and Interest Free Medical Advance seeking sanction for relaxation under KGSMA Rules 1960 are received in Health & Family Welfare Department. Malpractices and discrepancies have come to the notice in several applications and in the recommendations of Authorized Medical Attendants. Suppression/manipulation of facts, leaving blank spaces in the application, etc. have become frequent. Huge expenditure from the State exchequer is involved in such cases. In order to control loss of public money and also to ensure that ineligible persons are not availing financial assistance, it has become necessary to verify the admissibility of claims, more strictly. Therefore the following instructions are issued for strict compliance of all concerned.

- (a) All certificates issued by the Authorized Medical Attendant should contain his Registration Number, Date, Name, Designation and Seal and Name of Hospital.
- (b) No column should be left blank in the application.
- (c) Requests for Medical Reimbursement and Interest Free Medical Advance should be in conformity with the KGSMA Rules 1960 and Circulars issued there under.
- (d) Proposals should be examined thoroughly by the Heads of Department and Administrative Departments in the Secretariat and only those with the clear recommendation of the competent authority with proper justification need be hereafter forwarded to Health and Family Welfare Department.
- (e) Proposals which lack of sufficient details as mentioned above, will not be entertained in Health & Family Welfare Department, hereafter.
