ORDER

In para 1 of the G.O read as first paper above, it was ordered that in case the amount of loan applied for is less than the amount admissible to an applicant under the Rules and in case the applicant's subsequent request for the grant of the full eligible amount after the issue of the title certificate by the Government pleader the fee for the additional amount e has since applied for and that the full amount will be sanctioned only on production of the receipt for the payment of scrutiny fee for the additional amount.

The procedure regarding the payment of scrutiny fee to Government Pleaders at the time of application for original and additional advances has been reviewed and Government are pleased to order that scrutiny fee for additional loan need be [aid only where additional scrutiny is done by Government Pleaders, If documents are forwarded to the Government Pleader for scrutiny in connection with the additional loan such cases will have to be considered as separate applications and the fee prescribed in G.O.(P)2/Law dated 1-11-58 will have to be paid. The Heads of Departments will ensure that applicants do not split the eligible amount of advance with a view to evading payment of scrutiny fee.
