## ORDER

Item (ix) in Para 2 of the G.O. read above stipulated that deputation of employees/officers for training at State Government Expenditure will not be allowed. But officers of State Government Public Sector Undertakings/Autonomous bodies are permitted to attend training programme, fellowships etc. conducted abroad, where all expenditure outside the Country are met by foreign Governments/Organizations. In this context, the question of issuing appropriate orders for regulating the expenditure the has to be met by the State Government in connection with the deputation of Officers for participation in Training Programme, Fellowships, etc. abroad has been under consideration of the Govt. After having examined the, matter in detailed, Government are pleased to issue the following orders.

(i)In respect of the cases where the officers apply on their own(through State Government) to foreign Universities/Organizations etc. mp expenditure, including local costs, will be met by the State Government/Employer Organization in the event of selection of the officer and the officers should avail themselves of Leave without Allowance, for participating in the programme abroad.

(ii)As For the cases, where the candidates submit applications to Central Ministers/Autonomous Organization etc. in response to notifications issue by them, payment of salary for the period of the programme, and local costs will be admissible only if it is one of the specific conditions stipulated in the notification of the general scheme of the programme. In the other cases, the officers should avail themselves of leave Without Allowances and mo expenditure will be met by the State Government/Employees of the Officer, in the programme abroad

(iii)For those cases where officers are sponsored by State Government in response to Government of India Communications inviting nominations for approved Training programmes/Courses of studies etc. salary will be admissible for the entire period of training and the entire expenditure on local costs will also be met by the State Government.
