Sri.K.Shajeev, S/o.Late Shri.K.Velayudhan, Steward Guest House, Kozhikode and applied for the post of Lower Division Clerk under the Dying in Harness Scheme. Shri. Shajeev had produced all relevant documents in support of his claim for job. All other legal heirs of the deceased had consented for giving job to Shri.K. Shajeev. The deceased Sri.K.Velayudhan had 30 years 11 months and 26 days of qualifying service at the time of his death.

- 2. Director, Tourism Department as per the letter read as third paper above has recommended the application. District Collector Kozhikode has recommended the application subject to the verification of the service of the deceased. The service of the deceased was verified with his Service Book and found correct. As per the application read as 5th paper above Sri. Shajeev has requested for getting employment as Forest Guard since there is considerable delay in getting the post of Lower Division Clerk. He has produced the requisite Medical Certificate. The Chief Conservator of Forests has reported that there is a vacancy in Thrissur Circle to provide Shri. Shajeev as forest Guard as per letter read as seventh paper.
- 3. Government have considered the application in detail and are pleased to order that Shri. Shajeev.K.S/o.late Sri. K.Velayudhan, Steward, Guest House, Kozhikode in the Department of Tourism, will be appointed as Forest Guard in Forest Department Thrissur
