ORDER

As per Government Decision No. 1 below Rule 44 part 1 Kerala Service rule, it has been clarified that House rent Allowance admissible under the orders issued from time to time will be payable during periods of all leave with allowance for the first four months of such leave. Government Decision No. 2 provides for the payment of House Rent Allowance to officers who go on commuted leave preparatory to retirement and who retire on such leave subject to the limitation prescribed under Government Decision No.1 above.

- 2. The intention of Government is to allow House Rent Allowance admissible to Government Servants who go on all a kinds of regular leaves with allowance namely Earned Leave, Half Pay Leave and Commuted Leave as leave preparatory to retirement. Government decision no .2 could be interpreted that House Rent Allowance will be payable during commuted leave taken as preparatory to retirement, but will not be admissible during other kinds of leave with allowances taken as preparatory to retirement
- 3. Government have therefore, examined the matter in all its aspects and are pleased to modify Government Decision, No. 1as follows.
 - 4. Rule 44 Part. I Kerala Service Rule Government Decision No. 1.

"House Rent Allowance admissible under the orders issued from time to time will be payable during periods of leave with allowances including leave preparatory to retirement if the total period of such leave at a time dose not exceed four months or if the actual duration of the leave exceeds four months for the first four months of such leaves."

5. Government are also pleased to order that the Government Decision No. 2 below Rule 44 part I Kerala Service Rules shall be deleted.
