## ORDER

District Councils or each Revenue District came into existence in the State with effect from 5-02-1991. As per the G.O. read above orders were issued placing Government employees at the disposal of District Councils for their proper functioning.

- 2. According to Sub-section (1) of section 32 of the Kerala District Administration Act, 1979, the Collector of the District shall be the ex-officio Secretary of the District Council concerned and its Chief Executive Officer. The said section also empower the government to appoint such number of officers of appropriate rank from Government service as Joint Secretaries, Deputy Secretaries and Assistant Secretaries for the District Councils concerned to assist the Secretary in the administration of the District Council.
- 3. The following officers are the Division Chief of the different offices transferred to the District Council concerned.
- 1. The Assistant Controller (weights & Measures)
- 2. The Deputy Collector (Housing)
- 3. The Executive Engineer
- 4. The District Soil Conservation officer
- 5. The Principal Agricultural officer
- 6. The Assistant Conservator of Forests (Social Forestry)
- 7. The Assistant Dairy Director
- 8. The District Animal Husbandry officer
- 9. The Assistant Director of Fisheries
- 10. The Manager, District Industries Centre
- 11. The Assistant Registrar, Project office (Coir)
- 12. The District Medical Officer (Health)
- 13. The District Medical Officer (Indian System of Medicine)
- 14. The Chief Medical Officer (Homoeo)
- 15. The District Audit Education Officer
- 16. The District Development Officer
- 17. The Tribal Extension Officer
- 18. The District Social Welfare Officer
- 19. The Assistant Development Commissioner
- 20. The District Planning Officer
- 21. The deputy Director of Education
- 22. The District Educational Officer.

Many of the functions of the Panchayats, District Panchayat officer and the-District Town Planning officer will come under the immediate supervision of the District Council concerned.

- 4. Government have already issued orders that the district Councils concerned shall have complete supervisory control over the District educational Officers and Deputy Director of Education of the Government in the respective District dealing with matters in respect of functions entrusted to the District Councils.
- 5. Government have decided that according to the rank of these officers in Government service, they may be appointed ad ex-officio Joint Secretaries, Deputy Secretaries and Assistant Secretaries to the District Councils concerned. In the circumstances Government of Kerala hereby appoint.
- (i) The executive Engineer, Principal Agricultural Officer. District Animal Husbandry Officer, Manager District Industries Centre, District Medical Officer (Health) District Medical Officer (ISM), District Town Planning Officer, District Planning Officer And Deputy Director of Education of the District as ex- officio Joint Secretaries to the District council concerned.
- (ii) The Assistant Controller (weight & Measures), Deputy Collector (Housing), District Soil Conservation Officer, Assistant Director of Fisheries, Chief Medical Officer (Homoeo), District Adult Education Officer, district Development Officer, District Social Welfare Officer, Assistant Development commissioner, District educational Officer and District Panchayat Officer of the District as ex-officio Deputy Secretaries to the District Councils concerned.
- (iii) The Assistant Registrar, Project Office (Coir) and Tribal Extension Officer Of the District as ex-officio assistant Secretaries to the District council concerned.
