ORDER

It is reported that Shri. K.J. Joseph, I.F.S. (19621-1/2), Principal Chief Governor of Forests and Shri. N. Madhavan Pillai, I.F.S. (1962-1/2, Managing Director, Kerala Forests Development Corporation in the grade of Principal Chief Conservator of Forests, are retiring from service on superannuation on 30-6-1991, Government are Pleased to promote Shri. G.Mukundan ,I.F.S. (1963) and Shri. M. Srachandran Nair, I.F.S. (1963-1/2), the two senior most Officers in the grade of Chief Conservator of forests (on Rs. 5,900—6,700), to the grade of Principal Chief Conservator of Forests (on Rs. 7,300—7,600) in the place of S/ Shri K.J.
