<u>ORDER</u>

In para 6 of the Government Order, read above, it was ordered that the arrears of salary from 1.7.88 to 30.11.89 will be credited to the P.P account of the employees concerned. It was also ordered, vide para 55 of the order read above, that those who retires since 1.7.88, will be paid arrears of salary is full is such and that those in whose case it is not obligatory is maintain P.F. Account, is. Provisional Employees, personal staff of Ministers and Part-time Teachers/part-time contigent Employees will be paid the arrears of salary in cash in one instalment on retirement or on termination of services. Certain doubts have been raised regarding the disbursement of arrears of salary is accordance with the above orders. Government hereby order that para as of the Government Order read above will be substituted as follows.

55. "Those who retired from 1.7.88 till 30.11.89 will be said the arrears of salary in full in cash. Those in whose case it is not obligatory to maintain P.P accounts, ie., Provisional Employees, Personnel Staff of Ministers, and Part-time Teachers/Part time Contingent Employees will be said the arrears of salary in cash is one instalment on or after 1.4.1980 or an retirement whichever is earlier. Those who retire or relinquish services as or after 1.12.89 and who plant not to subscribe to the General Provident Fund (Kerala) in accordance with Rule 10 of the G.P.P. Rules, will also be said the arrears of salary is lumps on their retirement or terminations of servant."

Gusseted Officers who become eligible to get the arrears of salary for the period from 1.7.88 to 30.11.89 credited to their General Provident Fund Accounts as per the above orders and in whose case the Accountant General has authorized withdrawal of arrears only after their retirement as the pay slips above orders and in whose case the Accountant General has authorized Repetion of arrears only after their retirement as per the pay slips already issued by him may raw up the arrear bills and send then to the Accountant General for permission for crediting the amounts to their General Provident Fund Accounts now itself. In the case of Non-Gazetted Officers the drawing officers will take notion to credit the amounts to their General Provident Fund Accounts.
