#### ORDER

In the O.M. read as 1<sup>st</sup> paper above Government of India have fixed the pay of re-employed Emergency short service commissioned Military Officers by allowing advance increments for each completed year of service rendered by them in the Armed Forces provided the basic pay does not exceed the basis pay drawn by them in the armed Forces.

The Director of Sainik Welfare and Accountant General (A & E) Kerala, In their letters second and third referred to have suggested that orders analogous to the Government of India O.M read as first paper above may be issued by the State Government.

Government after examining the question in detail are pleased to extend the benefit read in the O.M to the Emergency short service commissioned officers who are re-employed under the State Government . Accordingly the Emergency short service commissioned officers who joined pre-commissioned training or were commissioned after 10-1-1968 may, on their appointment in Government service to unreserved vacancies, be granted advance increments equal to the completed years of service rendered by them in the Armed Forces on basis pay (inclusive of deferred pay but excluding other emoluments) equal to or higher than the minimum of the scale attached to civil post in which they are employed. The pay so arrived at should not, however exceed the basic pay (including the deferred pay but excluding other emoluments) last drawn by them in the Armed Forces, When the minimum of the scale of pay in the civil post to which a pensioner is re-employed is more than the last pay drawn by him before retirement his initial pay in the civil post shall be fixed at the minimum of the scale of pay of the re-employed post.

This order is applicable only in respect of all appointments made on of after 1-

7-1986.
