ORDER

As per Rules, officers who are deputed for training should execute bonds undertaking to serve the Government after training for a specified period. In G.O. read as 1st paper above, it was ordered that Government would not insist on enforcing the terms of the bond in respect of officers who leave the State Government service for taking up employment under any organization wholly or substantially financed and controlled by the Government of India/State Government. In the G.O. read as 2nd paper above, it was further ordered that a fresh bond should be taken from such Government servants to ensure that they serve the new employer for a specified number of years, the exact period being determined in each case by the department concerned taking into account. The amount spent by then on training.

2. It has come to the notice of Government that under cover of the above orders many technically trained employees get exempted from the bonded obligation. To work in other areas. Government feel that it is not advisable to exempt such employees from obligation. Government have examined the matter in details and pleased to order that bonded obligation will not be relaxed in respect of technically trained officers in the scarce categories for taking up appointments in other areas where the expertise Gained at government expenses cannot be utilised.
