Sub: Provident Fund-General Provident Fund (Kerala)-Measures to ensure compulsory subscription to Provident Fund- Revised instructions issued.

In the Circular cited, it has been directed interalia that in the case of the Non-Gazetted Officers other then those who are authorized to draw their own pay bills, the drawing officers shall furnish the following certificate in the establishment pay bills for July, 1966.

"Certified that all Non-Gazetted of my office who are under the rules of the Fund, required to join the General Provident Fund (Kerala) as on 31-12-165 have joined the Fund".

The Treasury Officers were also directed not to honour the pay bills for July, 1966 in the absence of the above certificate.

- 2. The Chief Engineer (General & Irrigation) has now brought to the notice of the Government that in Several cases the applications for admission to the Provident Fund, forwarded to the Accountant General have not been received back, duly admitted and that certain applications returned by the Accountant General are being retransmitted the defects pointed out by him, with the result that it may not be possible for the drawing officers to furnish the prescribed certificate in the establishment pay bills for 7/66.
- 3. The difficulty pointed out by the Chief Engineer would be felt by the drawing officers in other departments as well. With a view to removing this difficulty, Government are pleased to order that the certificate prescribed in Para 2(b) of the circular cited, will be modified as follows:-

Certified that all N.G.Os of my office who are, under the rules of the Fund, required to join the General Provident Fund (Kerala) as on 31-12-1965, have joined the Fund or have applied for admission thereto and that the pay and allowances of those who have neither joined nor applied for admission to the Fund without valid reasons have not been drawn in this bill."
