**ORDER**

According to the v<sup>th</sup> schedule to the States Reorganization Act 1956 the pension of Government employees affected by States Re organization will be apportioned among the successor states . The question arose whether a successor State could relax or liberalize the pension rules on or after 1-11-1956 without consulting the other concerned successor Status .

At the southern Zonal Council Meeting held on 15-5-1967 at \*\*\*\* the above quest in of allocation of pensioner liability between the successor States consequent on the reorganization of States was considered , . It was agreed that all the member States would enter into mutual agreements to the effect that they may have freedom of action to liberalize the rules relating to pension and enhance rates of pension etc. and that the liability arising out of such liberalization shall be apportioned among the successor states in according with the principles laid down in the vth schedule to the States Re- organization Act 1956 as the existing provisions of rules do not cover such issues .`

Accordingly the Government of Tamil Nadu , Andhra Pradesh and Mysore have given their general concurrence to the proposal that the States shall have freedom of action to liberalize the rules etc. without consulting the other states and their the enhanced pensioners liability shall be allocated in accordance with the provisions of the States Reorganization Act 1956.

The Government therefore direct that in such cases the pensioner liability shall be allocated among the concerned States in accordance with the provisions of the States Reorganization Act 1956 . The Accountant General concerned shall raise / receive debits accordingly.

Necessary amendments to the relevant rules in Kerala Account code will be issued separately .
