ORDER

The procedure for payment of anticipatory pension to retired Non-Gazetted Officers on whose cases pension papers could not be sent to the Controller of Accounts till the date of retirement was presented in the G.O first cited. Taxing into account the suggestions made by the Controller of Accounts to his letters second cited, Government are pleased to issue the following further orders.

- (i) Certain additional columns will be provided in the Bill form for drawal of anticipatory pension/gratuity. Accordingly the revised Bill Form attached to this order as Appendix I will be used in substitution of the Form prescribed in G.O. dated 7..8..1969.
- (ii) The Bill Forms will be printed in yellow colored paper so as to distinguish them from ordinary pension payment vouchers.
- (iii) The due for presenting the bills for anticipatory pension will be the first working day of every month after the month to which the claim relates.
- (iv) The pension sanctioning authority will issue a procedures sanctioning anticipatory pension in each case. A specimen form of the proceedings is enclosed as Appendix II. One copy of the proceedings will be attached to the first bill presented to the treasury claiming anticipatory pension.
- (v) The pension sanctioning authorities will record the grant of anticipatory pension in the Service Book and copy of the proceedings will also be attached to the pension papers.
- (vi) The entire charges on account of anticipatory pension/D.R.Gratuity drawn and paid by the departmental Officers will be **debited to Kerala Under''65 pension and other retirement benefits''. The Controller of Accounts will take the allocation when the payment is finalized.
