ORDER

The existing Provident Fund Rules provided that when the amount standing to the credit of a subscriber becomes payable: the interest thereupon normally payable is up to the end of the month preceding that in which the payment is made or up to the end of the sixth month after the month in which such amount becomes payable, whichever of these periods be less. Orders were issued in the G.O. first cited authorizing the Accountant General for a period of 2 years from 1-7-1960 to make payment of interest on a period of one year, after he has personally satisfied himself that the delay in payment was occasioned by circumstance beyond the control of the subscriber and that administrative delays involved in the matter fully investigated and action taken. This benefit was extended from time to time on the basis of the corresponding orders issued by the Government of India, Ministry of Finance, the last extension being for a period of two years from 1-7-1969 as per G.O.read as 3rd paper above.

The Government of India in their Office Memorandum read as 4 th paper above have extended the period of benefit in respect of Central Government employees for a further period of one year with effect from 11-3-1971.

Government have considered the desirability of extending the benefit in the State also and are pleased to order that the benefit of the orders issued in the G.O. cited as 3rd paper above will be extended for a further period of one year from 1-7-1971
