**NOTIFICATION**

S.R.O.No.708/77-In exercise of the powers conferred by subsection (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following amendments to the Kerala Service Rules, namely:-

**AMENDMENTS**

*(C.S.No 327/77)*

Part III of the said rules,

- (1) after rule 117, the following rule shall be inserted namely:-  
117 A

If the amount of final pension granted to an officer is afterwards found to be in excess of that to which he is entitled under the rules, the pensioner shall be liable to refund such excess amount to Government, when any amount is liable to be refunded under this rule, the sanctioning authority shall serve on the pensioner a notice retiring him slash/her to refund the amount paid in excess within period of two months from the date of receipt by him/ her of the notice. On his/her failure to comply with such notice, the sanctioning authority shall order that such excess amount shall be adjusted by short payment of pension in future in such number of installments as the authority may order. A similar procedure shall be adopted in the case of family pension also.

2. In annexure III to chapter VIII in the "from of enquiry report" for the words "Tahasildar" and "Taluk occurring at the end the following shall be substituted, namely:-

## **Explanatory Note**

The Accountant General in his letter reads 1<sup>st</sup>. paper above pointed out that the present system of furnishing the Enquiry Report by Tahsildar results in delay in the settlement of the claims or pension and suggested the furnishing of the reports by the Head of Office instead of Tahsildar. So also the necessity to have a provision authorizing. Accountant General to recover the amount of pension/Death-cum-Retirement Gratuity from the pensioners/heirs of pensioner if paid in excess was discussed in his letter cited.
