ORDER

- 1. With effect from 1-10-1976, the Provident Fund Accounts of Central Government employees are maintained by the pay ad Accounts Officers of the Departments. According to the existing procedure prescribed by the Government of India and accepted by the State Government, all inter-governmental transactions have to be effected by cheques/ drafts. The Accountant General has therefore stated that a procedure may be prescribed for accounting the Provident Fund transactions of the General Government Employees on deputation to the State Government to their accounts; in accordance with the principle governing the settlement f inter governmental transactions.
- 2. After examining the question. Government are pleased to issue the following orders:-
- (i) Provident Fund subscription and Recovery of Advances:
 Provident Fund remittances in respect of deputationists from Central
 Government to State Government will be made by demand drafts in favour of the
 concerned Pay and Accounts Officer.

(ii) Drawal of Advances:

No bills for drawals of advances should be presented at the treasury by the drawing officer. Sanction for drawal of advances will be sent to the concerned Pay and Accounts Officers for issuing necessary Demand Drafts.

3. In Cases where the drawing officers of the State Government do not get the details of the Pay and Accounts officer whom the demand drafts are to be sent, they will address the parent office of the Central Government Employee from where has been deputed to the State Government.
