**ORDER**

In the G.O. read as second paper above Government have issued orders setting out the procedure to be followed by the Heads of Offices (Gazetted) for the disbursement of the amount due to the legal heirs of the subscribers to the Family Benefit Scheme who die while in service. Apart from the instructions issued in the above Government orders, Government feel that there should be some safeguards for ensuring that amount sanctioned by the Heads of offices is paid only to those who are entitled to it. Government have considered the question and are pleased to issue the following further orders in the matter:-

(i) In the case of death while in service, the Drawing and Disbursing Officer concerned should sanction payment under the scheme with reference to the nomination filed by the deceased subscriber. Payment should be made only to the person or persons nominated by the deceased subscriber. The drawing and Disbursing Officers will also record a certificate in the following form in the bill to be presented at the Treasury, along with a copy of their proceedings sanctioning payment.

“Certified that the deceased had made the required nomination”.

(ii) In cases of this type, where any of the persons nominated happens to be a minor, the amount due to him under the scheme should be deposited by the Drawing and Disbursing Officer as term deposit in the Treasury Savings Bank to mature on the minor attaining majority. The fact that the amount will be so deposited should be specifically mentioned in the proceedings to be issued by the Drawing and Disbursing Officers.
