ORDER

According to the orders contained in Para (viii) of the G.O.read as second paper above, subscribers to the Family Benefit Scheme who are on deputation/ Foreign service, themselves will arranged for effecting recovery and remittance of the amount from their pay. A question has now arisen as to who should maintain the accounts of their deductions towards the Family Benefit Scheme. Government have examined the question and are pleased to issue the following orders:-

2. In the case of officers on deputation the employee will remit his monthly subscription towards Family Benefit Scheme by money order at his cost to the Head of Office under whom he worked immediately before his deputation to foreign service. The Drawing and Disbursing Officer of the concerned office will, immediately after the receipt of the Money Order in his office, send a receipt in form T.T.5 to the individual concerned. The Drawing and Disbursing Officer should also account the amount in his cash book and remit the amount immediately in the Treasury with which he has transaction, with necessary Chelan and supporting Schedules. He will account the credits so received by money order in the register-cum-broadsheet maintained in his office for noting the deduction relating to Family Benefit Scheme as prescribed in the G.O.read as fourth paper above, in the month in which remittance is made by him in the treasury.
