Sub: Additional Emoluments (Compulsory Deposit) Act, 1974-Repayment of annual instalments in July, 1980.

Ref: Circular No. 42/80/Fin. dated, 27-5-1980.

Instructions have already been issued to the Drawing and Disbursing Officers in the circular cited for the payment of the following instalments of Compulsory Deposits made by the employees under the Additional Emoluments (Compulsory Deposit) Act, 1974 which fell due on 6^{th} July, 1980.

- (i) The fifth and final instalment of additional Dearness Allowance deposits for the period ended 30th June, 1976 which are held in the additional Dearness Allowance Deposit Account (New) [A.D.D.A. (Old)].
- (ii) The third instalment of Additional Dearness Allowance deposits for the period subsequent to 30th June, 1976 which are held in the additional Dearness Allowance Deposit Account (New) [A.D.D.A. (New)].
- 2. A review of the progress of repayment reported by the Director of Treasuries shows that inspite of the above instructions the progress of repayment is very poor. It is seen that this is due to non-representation of claims by the Drawing and Disbursing Officers in time. The Government of India have asked the State Government to ensure that the repayments of the current year's instalments are completed before the end of August, 1980 as indicated in the circular cited. The Heads of Departments are requested to take immediate and effective action for the repayment of the instalments due in July, 1980 so that the same could be completed by the end of October, 1980.

The Drawing and Disbursing Officers concerned will furnish a certificate with their own salary bill for October, 1980 to the effect that repayments in respect of the Compulsory Deposit instalments which fell due in July, 1980 have been completed. Treasury Officers will not honour the salary bills of such officers for October, 1980 who fail to furnish such a certificate.
