In Para 3 of the Go read as first paper above pensioners who retired prior to 1-7-1978 have been ground into 4 categories for grant of relief at different rates with effect from 17-7-1978.

- 2. The Accountant General in his letter read as 2nd paper above has sought certain clarification relating to the percentage increase to be allowed as sanctioned in Para (3) of the said GO to the 4 categories of pensioners whose pensioners whose b pension commenced from 14-11-1966, 1-4-1969*, 1-7-1973 and 1-7-1978.
- 3. Government have already issued clarification in respect of those who have retired on the A.N OF 30-6-1978 (PENSION COMMENCED FROM THE FN of 1-7-19788) as per Government letter read as $3^{\rm rd}$ paper above to the effect that this category of pensioners as entitled to get the increase at the rate of 5 % mentioned in pare 3 of G.O. (P) 456/79 (41) Fin dated 5-5-1979.
- 4. Government arte pleased to issue the following clarification in respect of the other 3 categories mentioned in Para (2) above.
 - (i) The Pensioners who retired on A.N OF 13-11-1966 (Pension commenced from 14-11-1966 will also be allowed 25% increase in pension subject to maximum of Rs 50 as laid down in the GO DATED 5-5-1979.
 - (ii) As the pensioners whose last day of service was 31-3-1969 were also eligible for counting a portion of Dearness Allowances as Dearness pay for pension commenced from 1-4-1969) need be allowed only the increase of 10% pension subject to a maximum of rs 25%
 - (iii) The pensioners who retired on 30-6-1973 A.N (Pension commenced from 1-7-1973) will be eligible for the increase of 10% of pension subject to a maximum of rs 25/-
