ORDER

At present pension or family pension is payable monthly on and after the 1st day of the following month under RULE 123PART 111, kerala Service RULES . But in cases of death of the pensioner during the course of a month , elaborate enquires are required to determine the successors of the deceased pensioner for the disbursement of the life time arrears . This results in much work in treasuries , offices of the District Collectors and other revenue offices besides causing great inconvenience to the claimants . In order to simplify the procedure in such cases and for speedy settlement of pension claims the Accountant General made certain suggestion for the consideration of Government .

- 2. Government have examined the suggestion in details and are pleased to order as follows.-
- (i) As pension is a monthly payment for subsistence and not a payment for days of work , pension will be made admissible for the entire month in which death takes place instead of till the day of death as at present . Family pension would then be made payable from the $1^{\rm st}$ of the following month , instead of the present procedure for payment of the same from the day following the date of death of the pensioner .
- (ii) In order to avoid payment of arrears of pension for part of a month the pensioners will be allowed to draw their pensioners will be allowed to draw their existing procedure will be followed.
- 3. In cases where pension could not be drawn on the due date and the pensioner dies leaving some arrears the existing procedure will be followed.
 - 4. These orders will take effect from the date of issue.
- 5. Amendments to the relevant rules in kerala Service Rules, Part 111 will be issued separately.
