NOTIFICATION

S.R.O.No.46/82. In exercise of the powers conferred by clause (2) of article of the Constitution of India, the Governor of Kerala here by makes the following rules further to amend the Kerala Treasury Rules, namely:-

Rules

C.S.No.19/81Fin. Dated, Trivandrum, 11th December 1981.

- 1. (i) These Rules may be called the Kerala Treasury (Amendment)Rules,1981.
 - (ii) They shall come into force at once.
- 2. In the Kerala Treasury rules, in sub (a) of rule 293, for Instruction 1, the following shall be substituted, namely:-

"Instruction: 1.-If a pensioner alleges, loss of his half of the pension payment order, he should make an application with the prescribed fee of Rs.2 to the officer-incharge of the District/Sub Treasury from which he is receiving his pension, for a duplicate copy thereof. The Sub Treasury Officer will then forward the application received by him to the District Treasury Officer along with the Treasury half of the Pension Payment Order after duly furnishing his remarks on the application. The District Treasury Officer will after duly furnishing his remarks on the application. The District Treasury Officer will then conduct such further enquiries as are deemed necessary on such applications and thereafter, issue a duplicate of the pensioners half, prominently marked 'Duplicate'in red ink.

Explanatory Note

This note is not part of the amendment, but is intended to indicate its general purport)

At present when a Pension Payment Order available with the pensioner is lost, the District Treasury Officer can issue a duplicate Pension Payment Order only after publishing a Notification in the Government Gazette calling for objections if any. In fact no real purpose is served by calling for objection from other for the issue of a duplicate P.P.O. in lieu of a lost one. Hence the amendment.
