Sub:- Additional Emoluments (Compulsory Deposit) Act ,1974-Additional Dearness Allowance Deposit Account-Repayment of annual instalments due in July, 1980-Further Instructions Issued.

In the Circular Cited first, instructions were issued to all the Heads of departments of Additional Dearness Allowance Deposits due in July, 1980that the same could be completed by the end of October, 1980. The Treasury Officers were also directed that the salary bills for October 1980 of the Drawing and Disbursing Officers need be honoured only if they certify that the repayments in respect of Compulsory Deposit instalment s which fell due in July. 1980 have been completed.

2. Subsequently it has been brought to the notice of Government that certain Drawing and Disbursing officers could not produce the certificates as directed in the Circular cited first along with their salary bills for October, 1980 and claim their salary for that month and thereafther on account of certain practical difficulties in setting the accounts in case involving deaths, bership certificates, deputations ect. Accordingly, the circular read as Second paper above, the Treasury Officers were directed to honour the salary bills of Drawing and Disbursing Officers who could not produce the certificates required from October,1980 onwards also, if they produce a declaration to the effect that they will complete the repayments in all case which fell due in July, 1980 before the 31st March, 1981 where the claimants turn up for receiving the amount.

- 3. The Government of India , in their letter cited third have pointed out that continuance of staff for maintenance of Drawing and Disbursing Officers. Wise/specified authority-wise accounts on the basis of the number of accounts under both old and new Additional dearness Allowance Deposit accounts is allowed only as a taken to ensure completion of the overdue instalments before the end February, 1981 and that no further extension of posts in respect A.D A. (Old) accounts in the next financial year would be possible. It has there fore become quite inevitable that the repayments of the instalments the Additional Emolument (Compulsory Deposit) Act, 1974 which fell due July, 1980 should be completed before the end of February, 1981Accordinglyin modification of the circular second cited, Heads of Departments are requested to see that the repayment that the instalments due in July , 1980is completed by the end of February, 1981 positively.
- 4. The Drawingand Disbursing Officersconcernedshouldfurnishcertficate withir own salary bill for February, 1981 to the effect that repayments in respect of the Compulsory Deposit instalments which fell due in July, 1980 have been completed. The Treasury Officers shall not honour the salary bills for February, 1981 of such of the Drawing and Disbursing Officers who fail to furnish this certificate. They should also verify the correctness of the certificates furnished by the Drawing and disbursing Officers with the account kept in the Treasuries before honouring the salary bills in all case.
