ORDER

As per the G.O read as first paper above, the rates of deputation allowance admissible in foreign service have been revised with effect from 1-5-1979 and the contents of the have been incorporated in the Kerala Service Rules by way of an amendment to the Note 3 under Rule 144 Part I Kerala Service rules. A clarification has been issued regarding the rate of deputation allowances to be granted for the period from 1-7-1978 to 30-4-1979 as per the government Order read as second paper above. With a view to incorporation the decision in the G.O read as second paper above, in the Kerala Service Rules, Government are pleased to issue the following as Ruling No.2 under Rule 144. Part I, Kerala service Rules. The existing Ruling shall be numbered as Rulings No.1.

Ruling No.2: Under Rule 144, Part I, Kerala Service Rules (Ruling No.51/81)

- (i) For the period from 1-7-1978 to 30-4-1979, Officers on deputation will be allowed deputation allowance at the rates prescribed in the concerned government Order by which the deputation was sanctioned based on their prerevision pay in government Service.
- (ii) Those who continue to draw pay in the pre- revision scale on 1-5-1979 are eligible for deputation allowance from 1-5-1979 at the rates specified in Notes 3 above. But the minimum of the revised scales of the posts from which they are deputed, will be the basis for determining the rate of deputation allowance: pay in the pre-revision scale' means the pay the Officer concerned in the scale of pay as it stood as on 30-6-1978.
