ORDER

According to the Government decision under Rule102 (a) (i) Part III Kerala Service Rules, the reduction to civil pay contemplated in the said sub-rule in respect of a military pensioner re-employed will be effected only at the time of initial fixation and not on every occasion on which an increment is earned. It is not made clear in the rule whether the reduction contemplated in the case of re-employed personnel is to be effected every time the pay scale is raised or the individual is promoted to a higher scale.

The intention of Government, while framing Rule 103 (a) (i) was to have the effect of reduction in re-employment pay on account of military pension throughout the re-employment service of the person concerned. At such, the reduction should be made applicable not only for the initial fixation, but also on every occasion when revision of pay/promotion occurs. Government have examined the necessity of modifying the Government have Decision under Rule 102 (a) (i), Kerala Service Rules,Part III to make the position clear and they are pleased to order that the following will be substituted for the existing Government decision under Rule 102 (a) (i).

"The reduction in civil pay contemplated in the Sub rule on respect of a military pensioner re-employed is applicable throughout the re-employed service and will be effected not only at the initial fixation but also on every occasion of subsequent promotion/revision and will be subject to the condition that plus military pension and pension equivalent of other forms of retirement benefits foe the ,military service shall not exceed Rs.3,500 per month. The reduction will not , however , he effected when an increment is earned. In the case of promotion/revision of pay "the pay otherwise admissible (excluding reduction) shall be fixed under the normal rules in Kerala Service Rules with reference to "the pay otherwise admissible including reduction and including increments)and then reduction contemplated in the sub-rule shall be effected".
