ORDER

As per the orders contained in the references read as first and second papers above, the payment of D.A. to State Government pensioners, re-employed under the Government/Public Sector Undertakings is regulated as follows:-

(i) Re Employed-pensioners will be allowed to draw full D.A. along with the pension.

(ii) The employer (the concerned Government Department/Public Sector Undertaking) will deduct the amount of D.A. so drawn from the total remuneration payable to the pensioner on re-employment.

2. The Accountant General in his letter cited third, has brought to the notice of Government for consideration, the case of a re-employed family pensioner, whose D.A. on re-employment pay is less than the D.A. on his family pension.

3. Government have examined the question in detail and are pleased to clarify that in the case of re-employed pensioners (including family pensioners) where the D.A. on pension is higher than the D.A. admissible on the re-employment pay those re-employed pensioners will be allowed to draw the D.A. on pension in full and the adjustment of the D.A. so drawn against the D.A. on re-employment pay as contemplated in Government order read above will be effected only to the extent of the amount of D.A. on re-employment pay.
