ORDER

In the Government order read as first paper above, it was ordered that the Government of India rates of interest on General Provident Fund (Central Services) Deposits from time to time would be adopted by the State Government for all types of Provident Funds administered by the Government.

In the resolution read above the Government of India have announced that during the year 1986-87 accumulations at the credit of the subscribers to the General Provident Fund (Central Services) and other similar funds shall carry interest at the rate of 12% (twelve percent) per annum and that this rate would be in force during the financial year beginning on 1-4-1986. It has also been made clear in the resolution that there would be no separate incentive bonus and in cases where withdrawals (not in the nature of temporary advance) are made during the year an amount equivalent to one percent of the amount withdrawn rounded to the nearest rupee shall be deducted from the interest creditable to the account of the subscriber.

2. Government have examined the question in detail and are pleased to order that the interest at a flat rate of 12%(Twelve Percent) per annum will be allowed on all deposits and also on balances at the credit of subscribers of the following Providents during the financial Year 1986-87commencing on 1-4-1986.
