NOTIFICATION

S.R.O No..636/86- In exercise of the powers conferred by such section (1) of section 2 of the Kerala Public Service Act, 1968, (19 of 1968) read with section 3 there of, the Government of Kerala here by make the following rules further to amend the Kerala Service Rules, namely:-

RULES

(C.S.NO.13/86)

1. Short title and commencement (1) these rules may be called the Kerala Service (Amendment) Rules, 1986.
2. They shall come into force at once.
2. Amendment of Rules: - In Part III of the Kerala Service Rules, in rule 3.
“Note 3:-The liabilities of an employee should be qualified either before or after retirement and intimated to him before retirement. If possible or after retirement within within a period of three years on becoming pensioner. The liabilities of a pensioner should be quantified and intimated to him”.
