ORDER

In the G.O read above it has been ordered that part —time contingent employees who got appointment to full —time posts and retire at the age of 55 years ,and who are not eligible for any pension admissible for full time employees or the gratuity allowed for part —time contingent employees reckoning also their service rendered in full-time posts.

- 2. A state has come to the notice of Government where in a seasonal Ferrymen after rendering 32 years of Seasonal Service got appointment to full-time post and retired from service after putting in one year service in full-time posts. Under the existing orders he is neither eligible for pension admissible for full-time Ferrymen nor gratuity allowed for Seasonal Ferrymen.
- 3. Government have examined the question in detail, and are pleased to order that on the analogy of orders issued in the case of part-time contingent employees, the Seasonal Ferrymen of Public Works Department who get appointment to full—time posts and retire at the age of 55 years completing the minimum period of 5 years in the full time post and are not eligible for any pension admissible for Seasonal Ferrymen reckoning also service as full*-time Ferrymen. For the purpose of computing gratuity the emoluments which the employees would have got, had such employees continued under Seasonal Service will be reckoned.
- 4. Government are also pleased to order that excess pay drawn by such employees in full-time post for the period for which the full-time service is reckoned as seasonal service for the computation of gratuity will not be recovered.
 - 5. This orders will have effect from 31-3-1980.
