### CIRCULAR

- Sub: Pension-Government officers who are/were on deputation to public sector under taking/Autonomous Bodies-delayed settlement of pensionary benefits due to delay in issuing N.L.C./L.C.-Instructions Issued.
- Ref:- Letter No PR6/Pen. A/1238/84-85/1067 dated3-3-1986 from the Accountant General, Kerala, Trivandrum to the Secretary, P.W.D.Trivandrum.

Cases have come to the notice of Government where much delay is being caused to issue Non-Liability Certificate/Liability Certificate of Government Officers who are/were on deputation to Public Sector Undertaking/Autonomous Bodies on the plea that liabilities have not been assessed. If this position is admitted and allowed the Public Sector Undertaking/Autonomous bodies to settle the liability at their own convenience the r3 esul will be that the officers will not be able to get the Pension /Death-cum-Retirement Gratuity soon after their retirement.

In the circumstances the following instructions are issued for guidance.

1. In the case of Government officers worked/ are working of deputation to Public Sector Undertaking/Autonomous Bodies the Head of Department should intimate he Public sector Undertaking/Autonomous Bodies the actual date of retirement of such officers atleast before 18 months of their retirement.The Public Sector Undertaking Autonomous Bodies should settle the liability within a period of 12 months and inform the Head of the Department., In case of officers working on deputation till retirement the liability should be settled and intimated to the Head of the Department within one month from the date of retirement. This will be possible if the action to assess and settle the liabilities started 18 months prior to the date of retirement.

2 The Non-liability Certificate of the retired Officer will be issued by the component authority within two months of the retirement if the liability is not settled and intimated within the time schedule mentioned above by the Public Sector Undertaking, /Autonomous Bodies.

3 The issue of such Non-liability Certificate will be at risk and cost the Public Sector Non-liability Certificate will not be held respectable for any liability reported later. 4. The Public sector Under taking/Autonomous Bodies can initiate suitable action against pensioner for realizations of the liabilities of detected within a period of 4 years from the date of retirement.
