**ORDER**

As per Government orders read above, all Gazetted Heads of Offices are authorised to sanction temporary withdrawals upto a maximum of Rs.1,000 from the General Provident Fund in the case of employees working under them, if the withdrawals do not involve relaxation of rules or sending orders.

The Kerala Government Class IV Employees Union in their memorandum cited 11 have requested to enhance the monetary limit of General Provident Fund temporary advances that can be sanctioned by Gazetted Heads of Offices on the ground that they have to approach District Offices for withdrawals exceeding Rs.1,000 and experience much delay in such withdrawals.

Government have examined the request in detail and are pleased to order that all Gazetted Heads of Office are authorised to sanction temporary withdrawals upto Rs.2,000 (Rupees Two Thousand only) from the General Provident Fund account of employees working under them, if the withdrawals do not involve relaxation of rules or standing orders.

Necessary amendments to the Book of Financial powers will be issued separately.
