#### **ORDER**

At present , the family pension to the eligible members of the family of the employees who have disappeared and whose where about are not known is being considered on merits . As per section 108 of Indian Evidence Act , unless a period of 7 years has elapsed since the date of disappearance of the employee , he cannot be deemed to be dead and the retirement benefits cannot be paid to the family ,. The Government of India in their O.M read above have liberalized the settlement of pensionary claims in respect of man — missing cases. Government after examining the carious aspects of the case in consultation with the Account General , Kerala are pleased to issue the following instructions on the lines of the Government of India orders .

- (i) When an employee disappears leaving his family, the family will be paid in the first instance the amount of salary due, leave encashment due and the amount of General provident Fund having regard to the nomination made by the employee
- (ii) After the elapse of a period of one year the date of disappearance the pensionary benefits such as Death cum retirement Gratuity, family pension etc, will be granted to the family of the employee.
- (2) All such cases will be forwarded to the Government through the Head of Department for sanctioning payment along with the following documents .
  - (i) The certificate from the concerned Police station to the effect that the employee could not be traced out after all efforts had been made by the police.
  - (ii) An indemnity Bond in Stamped Paper from the legal heir / nominee of the employees stating that all payments will be adjusted against the payments due to the employee in case he appears on the scene and makes any claim.
- 3 The Head of Office will assess all Government dues outstanding against the Government servant and effect their recovery in accordance with the rule .

- 4 The family can apply n to the Head of Office of the Government servant for grant of family pension and Death Cum retirement gratuity after one year from the date of disappearance of the Government servant in accordance with the procedure prescribed for sanction of family Pension and Death cum retirement n Gratuity.
- 5 The concerned Administrative department of the Secretariat will sanction the benefits with the concurrence of the Finance Department.
