ORDER

The general principles and procedure for the integration of the former Travancore – Cochin personal and the staff allotted from Madras were laid down in the Government proceedings read as first paper above. According to the procedure laid down there in, a Committee was to be constituted by the Government immediately , to make recommendations to the Government on integration matters . In the Government Proceedings read as second paper, the government constituted a Committee consisting of the Chief Secretray and the three Members of the Board of Revenue as permanent members and the Head of the Department concerned and the Secretary to Government incharge of the Department as Co- opted members to advise Government on matters relating to integration f services . while the work of the above Committee was in progress , variations Service Associations represented to Government that they should be consulted in this regard . After careful consideration, the Government decided to constitute a second committee for integration of services consisting of one representative each of the seven service Association of the Travancore- Cochin and allotted personnel as members with Shri N.N . Chaterjee , I.A.S Deputy Secertary of the union Ministry of Home Affairs as its president to give its views on the proposals for equation of posts in

the various department and on such other matters connected with integration as it might consider useful . The deliberations of the second integration Committee and the views expressed by Shri Chaterjee on the equation of various postes are now before the Government , and orders will issue separately with refernce to each department . The Committee also considered the question whether the general principals for the integration of services enunciated in the government proceeding read as first paper should be allowed to stand or should be revised . The Government have carefully considered the delibration of the Committee and the views recored by Shri Chaterjee on this point and are pleased to order that the principles enunciated in the Government proceedings dated 29/12/1956 should stand , subject to one clarification , viz ., that for computing length of continuous services in deciding relative seniority envisaged in paragraph -4 of the Government proceeding dated 29/12/1956 only short periods for which an appointment was held in a purely stopgap or emergency arrangement will be excluded
