ORDER

With a view to safeguard the position of officers who had held officiating appointments in higher grade pots otherwise than in a purely stop-gap emergency appointment prior to 1-11-1956, it was ordered in the G.P. second cited to add the following note to paragraph 4 of the G.P read as first paper above laying down the general principle for effecting the integration of the Travancore –Cochin and Madras personnel as on 1-11-1956.

NOTE: The rights of officers of either branch who had held officiating appointments in higher grades or categories otherwise than in purely stop-gap or fortuitous a claim for reappointment 1-11-56 and had thereby established a claim for reappointment to those grades will be protected. Such persons will be assigned Performa rank in the higher grade or category and they will have prior claim to reappointment to those grades or categories irrespective of their rank in the lower grade or category.

2. On the representations of certain officers appealing against the orders contained in the G.P read as second paper, the Government of India have, in consultation with the Central Advisory Committee constituted under Section 115(5) of the States Reorganization Act, decided that the principle of assigning Performa rank to officers for previous officiating in higher grade posts prior to 1-1-1956 cannot be accepted.

Government accept the decision of the Central Government and they thereby cancel the orders issued in the G.P. Second cited. However, in order to alleviate the hardship of officers who had officiated in higher grade posts otherwise than in a purely stop-gap or emergency arrangement prior to 1-11-56 and who had to be reverted to lower grade posts be fore 1-11-56 for reas as other than unsatisfactory work, inefficiency or misconduct, the fact of their such officiating ill be noted against their names in the remarks column of the integrated gradation list as on 1-11-56 and they will be given higher ranks in the list of eligible drawn up fro purposes f promotion to vaccines in higher grade posts which arose on or after 1-11-56 irrespective of the ranks assigned to them in the lower grade posts in the final integrated gradation list as on 1-11-1956
