NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Kerala hereby makes the following amendments to the Kerala Service Rules, namely:-

AMENDMENTS

**C.S. No.10/62 dated 6th April 1962**

In the sail rules-

1. In Part I, in rule 117, the following shall be inserted as Note 5 namely:-

“Note5:- Reciprocal arrangements have been entered into with the Mysore Government to the effect that officers including Police personnel of one State while staying in the other will be examined free of cost by a medical board or a medical officer employed under the Government of the State concerned for the purpose of invalidating from Government Service. A medical requisition from the competent authority will be required before the medical examination is conducted”

2. in part II, the following shall be added at the end of rule 51 (c)

“For officers including Police personnel staying in Mysore State see note below rule 133 Part II”

3. In part III, in rule 133 (iv), the following shall be inserted as note, namely:-

“Note- Reciprocal arrangements have been entered into with the Mysore Government to the effect that officers including police personal of once State while staying in the other will be examined free of cost by a medical board or a medical officer employed under the Government of the State concerned for the purpose of invalidating from Government Service. A medical requisition from the competent authority will be required before the medical examination is conducted.

4. In the part of the appendix X, in rule 7(vi), the following shall be added as a more namely.

*Note:-* Reciprocal arrangements have been entered into with the Mysore Government to the effect that officers including Police personnel of one State while staying in the other will be examined free of cost by a medical board or a medical officer employed under the Government of the State concerned for the purpose of commutation of pension. A medical requisition from the competent authority will be required before the medical examinations conducted. The fees fixed for medical examination in this case should be borne by the pensioner”.
