PENSION – PERSONS ABSORBED IN WORK ESTABLISHMENT SERVICE  
AFTER WAR SERVICE-RECKONING OF WAR SERVICE FOR PENSION -  
FURTHER ORDERS ISSUED.

**ORDER**

In the G.O read government ordered as follows:-

(i) In the case of persons who have rendered war service with the permission of government while holding a work establishment post and who were subsequently reabsorbed in work establishment service, there war service will be treated as work establishment service for the purpose of rule 14 Part III, Kerala Service Rules, i.e. they will be entitled to count 50% of their war service admissible under rule 7 (b) ibid for pension and death-cum retirement gratuity.

(ii) This order will have retrospective effect from 1-11-1956 .Claims already settled will be revised on the basis of the order if specific requests are made by the persons concerned or their dependants.

(iii) In the case of those who retires on or after 14-11-1966, the break, if any, between war service and work establishment service will be condoned on the basis of the orders in G.O (P) 59/68/Fin dated 5-2-1968.

2. In G.O (P) 428/69/Fin dated 1-8-1969 Government have ordered that work establishment employees who are absorbed in regular establishment and who retire from service on or after 1-4-1968 will be allowed to count their entire full-time work establishment service for purpose of pension and other retirement benefits. The Orders already issued in the government Order read require modifications in the light og G.O (P) 428/69/Fin dated 1-8-1969.

The Controller of Accounts has also raised certain points for clarification.

4. Government are pleased to issue the following further orders:-

(i) In the case of those work establishment employees who were absorbed in regular establishment and who retire on or after 1-4-1968 their entire war service to the extent admissible under rule 7 (b) Part III, Kerala Service rules will be reckoned for pension and death- cum- retirement gratuity.

(ii) The Government order read only permits of counting of 50% of the completed years of war service admissible under rule & (b) Part III Kerala Service rules of those reabsorbed in work establishment service after war service. For the purpose all the conditions, for the counting of war service for pension have to be satisfied. In other words, in the case of those who retire before 14-11-1966, they will get the benefit of the Government order under reference only if they were reabsorbed in post the vacancies in respect of which arose prior to 1-1-1948. ( Break between war service and civil service i.e work establishment service is no bar in such cases) But in the case of those who retire and civil service (work establishment services) admissible under G.O.(P) 59/68/Fin dated 5-2-1968 will be available.

(iii) The orders are to count 50% of the war service admissible under rule & (b) Part III Kerala Service rules. As the maximum was service that can be reckoned for pension under the above rule is 5 years. For the purpose of the Government order read will be 2 ½ years. For the purpose of the government Order the completed years of war service admissible under rule 7 (b), Part III Kerala /Service Rules should be calculated first and its 50 % added to the regular service.

(iv) The break, if any, between initial work establishment service and war service will be regularised by the grant of leave without allowance under special orders of government in individual cases.

5. As the benefit of the government order read will be available only to those who have rendered war service with the permission of government all heads of offices will note on the service books of the persons concerned, that the deputation for war service was under the orders of government. The number and date of the order in which permission was granted should also be noted in the /Service Books under due attestation.
