## ORDER

In the timber auction held at Vadakanchery Range under the Divisional Forest Officer, Trichur on 18.7.1974. Teak poles were bid by Shri.V.K.Balakrishnan Nair at the cost of Rs.14315.50. But he did not remit1/3 of the sort of the Teak Poles bid by him at the appropriate time. Therefore, the earnest money deposit of Rs.500/- deposited by him was fortified to Government and the lots were re-auctioned on 30-9-1974 at the risk and loss of the original bidder Shri.Blakrishnan Nair . The Chief Conservator of Forests has reported that in the re-auction Government sustained a totals loss of Rs.7002.25 including Sales Tax, Advertisement Charges Etc. As Shri. Balakrishnan Nair , failed to remit the amount to Government he was blacklisted in the Government Order read as first paper above.

2. In the letter read as second paper above the Chief Conservator has also reported that efforts to recover the loss from the original bidder Shri. V K. Balakrishnan Nair have become futile. The Chief Conservator of Forest has also reported the the Tahasildar, Thalapilly has testified that the defaulter Shri. Balakrishna Nair does not possess any movable or immovable property and as such there is no scope of recovering the amount due from Shri. Balakrishnan Nair. Hence the Chief Conservator of Forest has recommended that the amount of Rs.7002.25 less the security amount of Rs.500/- may be wrillen off as it is irrecoverable.

3. In the circumstances sanction is accorded to write off the amount of Rs.6502.25 (Rupees Six thousand five hundred two and paise twenty five only) which is due from Shri.V.K.Balakrishnan Nair towards loss sustained by Government in the re-auction of Teak Poles held at Vadakkanchery Range on 30-9-1974.
