The Government by order 1st read above pending amendments to the Kerala Forest Subordinate Service Special Rules, restored the old provision of filling up of 10% of the vacancies in the posts of Foresters through recruitment by transfer from members of Ministerial Service in the Kerala Forest Department.

The Chief Conservator of Forests by circular order No.3rd read above, issued guide lines for the appointment of such persons. As per the guidelines, 10% of the vacancies in the category of Foresters shall be filled up by transfer from Ministerial Category of U.D. Clerks/L.D. Clerks who have the educational qualification of a pass in pre-degree and physical standards prescribed for direct recruitment. Further, it was clarified by the Chief Conservator of Forests vide order 4th read above, that the members of the Ministerial staff include Typists also. The sanctioned strength of the category of Foresters of Central Circle, Trichur include Social Forestry Wing, Wild life wing, vigilance and evaluation wing and Research Ranges functioning with the jurisdiction of the Central Region.

The Foresters appointed by transfer from Ministerial Wing shall be governed by Kerala Forest Subordinate service special Rules. Every person appointed by transfer from the date on which he joins duty will be on probation for a period of two years duty within a continuous period of three years.

Application for appointment by transfer, has been called for and the following members of Ministerial staff have requested for the posting.
