Read:- D.O. letter 8960/60 dated 27-6-1981 from the Chief Conservator of Forests.

ORDER

The Chief Conservator of Forests has, in his letter read above, stressed the necessity for appointing additional staff for bringing up to date the D.C.B. statements and the lease registers in the Trichur Division which are not properly maintained. He has also submitted proposals for the creation or additional posts of one Ranger and six foresters for a period of six months for the purpose.

2. Government have examined the question and are pleased to accord sanction for the creation of additional posts of one Ranger on Rs.150-300 and six Foresters on Rs.40-120 for a period of six months from the date of appointment, on condition that the work should be completed within this period, Any work if at all left undone should be attended to by the normal staff. The Chief Conservator of Forests should not move Government for extending the period of the additional staff on any account.

3. Expenditure on this account will be met from the provisions under “10 Forests”.

4. To allow work to fall into arrears and to make it a justification for appointment of additional staff cannot be countenanced. It is the duty of the normal staff to see that work does not fall into arrears and when the work has fallen into arrears it is their duty to clear off the same. If additional staff is allowed to clear off arrears of work it will be an encouragement to those who shirk work.

Forest Officer's No. TC2-2164/55 dated 22-6-61 and Conservator's No. A2-3464/58. The area to be covered will be split into 6 units each under a Forester and Range Officer will check the work done by each Forester and submit fortnightly progress statement to the Divl. Forest Officer. The Divl. Forest Officer will check 5% work of the Range Officer and send up copies to Conservator of Forests and Chief Conservator of Forests.

The work must be completed within six months. Conservator of Forests during his tour in the area, will call for the statement, and see that progress is maintained – Range Officer A. Achutha Menon, (Reeds Range Officer) is posted for this special work.
