ORDER

In the G.O. read as first paper above it has been ordered that pending issue of the Kerala Forest service special Rules direct recruitment and recruitment by transfer of Assistant Conservators of Forests will be made in the proportion of 3:2 and this will take effect from 1-11-1956. In the G.O read as 2nd paper above it has been clarified that the 3:2 proportion is applicable only to substantive vacancies in the permanent cadre. The appointment of directly recruited Assistant Conservators of Forests between 1-11-1956 and 28.9.1964 was regularized accordingly.

Now the Honorable High Court of Kerala in judgment in, O.P. 1441/63 filed by a Ranger promoted as Assistant conservator of Forests has held that rule 5 of the General Rules of the Kerala State and Subordinate Service rules 1958 which stipulates that direct recruitment can be made only against substantive vacancies does not come in to play so long as the Kerala Forest State Service Special Rules have not been issued and that the contention that under the Madras Rules direct recruitment of probationary assistant Conser4vators of Forest can only be against substantive vacancies in the permanent posts in the category has to be repelled Relevant extract from the judgment is given bellow:-

"Rule 2 of the Special Rules for the Madras Forest Service (vide, Madras services Manual, Vol.II, pages 72 to 74), proviso:

: Appointment to the several categories of service shall be made as follows:-Assistant Conservators.

> Direct recruitmen or recruitment Assistant Conservators, by transfer from Rangers of the madras forest subordinates Service.

Provided that substantive vacancies in the category of Assistant Conservators shall be filled in accordance with the seniority of approved probationers".

The Proviso above is clear that direct recruitments of probationary Assistant Conservators are not limited to substantive vacancies in permanent posts in the category, as has been vehemently contended by counsel for the petitioner and for some

others, and that the question of substantive vacancies in the category- not confined to permanent post therein- is relevant only at the time of confirmation of approved probationers in the Services. Rule 6 of Part II- General Rules of the Madras State and Subordinate Service Rules,(vide: Madras Services Manual, Vol.I, page 62) can not counter the above Special Rules in view of the express provision that the Special Rules will prevail over the General Rules (vide- Rules 2 of the General Rules). The contention that under the Madras Rules direct recruitment of probationary Assistant Conservators can only be against substantive vacancies in the permanents posts in the category has therefore to be repelled".

Government have examined the position in the light of this judgment and they are pleased to order, in supression of the G.O read as 2nd paper above, that the appointment of Assistant Conservators of Forests made since 1-11-1956 will be regularized applying the 3:2 ratio to all vacancies irrespective of permanent and temporary.
