ORDER

In the Government proceedings read sanction was accorded for the grant of certain concessions to retired officers , in the matter of reckoning emoluments drawn in an officiating capacity or in temporary posts for pension and the rules in the Travancore Service Regulations and the Cochin Service Regulations were also suitably amended (vide Article 325 A, Travancore Service Regulations and Article 217A, Cochin Service Regulations) By the G.O read as the forth paper the above concessions were extended up to 15-8-1968.

2. Under Article 487 B of the Madras Pension Code also retired officers are allowed certain concessions in the matter of reckoning emulations drawn in an officiating capacity or in temporary posts for pension . Originally only those Officers who retired from 1-1-1948 to 31-12-1957 were eligible for these concessions. By the Go read as the fourth paper these concessions were extended up to 31-12-1967.

3. Government has examined the question of extending the above concessions further. There is no intention to deny the concessions to those who are still in service and are governed by the Travancore Service Regulations , the Cochin Service Regulations and the Madras Pension Code . Government are therefore pleased to extend the Concessions in question up to 31-12-1972 , in respect of officers governed by the above three service Rules .
