ORDER

The Director of employment has forwarded proposals for effecting some amendments to the G.O.read above Government have examined these proposals and they are pleased to order the following amendments to the G.O. read above.

- (1) The words " in a Revenue District "occurring in paragraph 3 of the G.O. shall be modified to read as ' with in the area of jurisdiction of the Employment Exchange".
- (2) At the end of the sub para iii of para 3 of the G.O. the following sentence shall be added:
- "Such requests for supplementary lists will be considered by the Employment Exchanges only if the exact grounds of rejection are communicated in respect of every candidate advised earlier".
- (3) The following sentence shall be added at the end of sub-para V of para 3 of the G.O.
- " In case qualified candidates are not available in the priority group, those belonging the non-priority group should be sposerd Similarly in case qualified candidates are not available in the non-priority group, these belonging to priority group should be sponsored".
 - 4. The sub-para VI of para 3 of te G.O. shall be amended as follows.
- "The Employment Exchanges must note that the Communal rotation order should remain in for a till the cycle of 100 vacancies is completed. If there is no suitable candidate available for selection from the group of communities classified as O.B.Cc or from the group of communities classified as S.Cs and S.Ts in the turn allotted to them in the cycle the said group shall be passed over for making the selection. If however a suitable candidate is available for selection in the community or group immediately next to the passed over community or group in the said cycle, he shall be selected. If no such candidate is available in that community or group, selection shall be made from the community or group following strictly in the order of rotation. If no suitable candidate is available for selection in any of the said communities or groups, selection shall be made from among the open competition

candidates. The benefit of being passed over shall be restored to it, at the earliest possible opportunity, if suitable candidate from that community or group is available for selection by making adjustment such passing over.

Provided that in no year reservation including carrying forward vacancies to a category of past shall exceed 50% of the total number of vacancies for which selection to that category is resorted to in that year;

Provided further that the right of restoration of the turn shall lapse with the expiry of three years from the date of the passing over".

Provided also that the said right of restoration shall not extend to a case where the selection has gone to an open competition candidate."

(5) The paragraph 4 of the G.O. shall be amended as follows:

" The District / Divisional Employment officers or the Professional and Executive Employment officer, as the case may be, will be personally held responsible for the proper setting of the rotation order.

for the purpose of proper setting of the rotation order by the Employment Officers concerned, the appointing authorities shall inform the Employment Exchange about the result of selection giving reasons in detail for not selecting candidates from groups of communities for which vacancies were reserved as per the rotation rost and communicated to the appointing authorities by the Employment officers in the forms given in Annexure III".
