PUBLIC SERVANTS-DYING IN HARNESS- APPOINTMENT OF RELATIVES/
DEPENDENTS-FURTHER ORDERS ISSUED

ORDER

In the G.O. read as first paper above Government have prescribed the procedure for dealing with requests for appointment from relatives/ dependents of Government servants dying in harness . In the G.O. read as second paper above it was clarified that the G.O. read as first paper has no retrospective effect. In the G.O. read as third paper above it was further clarified that all candidates who had applied to Government prior to the issue of the clarification in the G.O.read as second paper be given the benefit of the G.O. Ms No 20/70/ PD dated 21-1-1970 irrespective of whether the officers concerned had died before or after that date.

A question has been raised as to whether the relatives/ dependents of Government servants who died in harness who had applied for employment assistance before the issue of G.O Ms.No.20/70/PD dated 21-1-1970, i.e; when there was no scheme for giving employment assistance, and whose applications were rejected before 21-1-1970 need be given the concessions contemplated in the said G.O. when they apply again before 30-8-1971.Government are pleased to order that the benefit of G.O.MS. No. 20/70/PD dated 21-1-1970 will be given to the dependents/ relatives Governments servants who died in harness prior to 21-1-1970 provided such relatives/ dependents had applied before 30-8-1971. This concession need not be restricted to applications received after 21-1-1970 . Government are also pleased to order as follows:-

1. The concessions contemplated in G.O. Ms. no. 20/70/ PD dated 21-1-1970 will not be available to relatives / dependents of teachers who continue in service after the date of their superannuation and who are under the rules permitted to continue in service till the end of the academic year and die after the date of superannuation but before the close of the academic year.
2. The concession contemplated in G.O.Ms. No. 20/70/PD dated 21-1-1970 will not be available to relatives/ dependents of Governments Government servants who died in harness prior to 21-1-1970, who could not apply for employment assistance before 30-8-1971 for the reason that they were then minors. But deserving cases will be decided by

Government if employment has not been given previously to any other relatives/dependents of the deceased.

3. When there are minor children of the deceased Government employees, employment assistance to brother/ sister of the deceased Government servant will be given only with the consent of the widow/ widower of the deceased Government servant or if the widow / widower of the deceased Government servant is not alive, with the consent of the guardian of the minor children.

4. Hereafter applications for employment from relative/ dependents of Government servants who died in harness will be entertained only in the prescribed form given in Appendix A, with a court fee stamp for Rs. two affixed thereon.

5. A check list as in appendix B will be adopted by Heads of Departments/District Collectors for making reports to Government on the applications for employment under the scheme.

9. Whether the applicant is married or single. (If married furnish the date of marriage)..
10. Applicant's present annual income and source there for (If married the income of both should be given together with source of each).
11. The quantum of family pension and gratuity received and name of person receiving family pension and his /her relationship with the deceased.
12. whether any other relative/dependent of the deceased Government servant has availed of the benefit of employment under the scheme previously

CHECK LIST OF POINTS TO BE LOOKED INTO FOR APPOINTMENT OF NEAR RELATIVES OF GOVERNMENT SERVANTS DYING IN HARNESS
